**IMPORTANT NOTE:** Any hours earned at Miami Nice will apply to the biennium which starts 3/1/19 and ends 2/28/21. Current Florida CE requirements for each biennium are 6 hours Florida TQ, 2 hours medical errors, 2 hours Florida jurisprudence, 2 hours on prescribing controlled substances, 1 hour in human trafficking, 20 additional hours in general topics (only two of which may be practice management), for a total of 30 hours. You can only get credit for Florida Jurisprudence or medical errors once in each biennium. (That means, if you take either one twice, you do not get any credit for the second course.) Due to requirements in other states for approving continuing education, the Miami Dade Optometric Physicians Associations will not be responsible for obtaining approval for these courses in advance. However, 12 hours will be COPE-approved. It is the responsibility of doctors licensed in other states to determine if these courses meet the requirements of their state. Of course, all courses will be approved in Florida.

**8:00 - 9:40 NEW FRONTIERS IN THE DETECTION & MANANGEMENT OF DIABETIC RETINOPATHY - TQ - A. Paul Chous, O.D.**

This course will consider both the vascular and neuro-degenerative components of diabetic retinopathy. Technologies applicable to early detection of both will be considered, along with specific evidence-based strategies designed to prevent or mitigate each. Recent findings from DRCR.net and other clinical trials involving anti-VEGF therapies for both DME and DR will be presented.

**10:00 - 11:40 DIABETES CASE STUDIES - TQ - A. Paul Chous, O.D.**

This talk will consider a number of diabetes and diabetes-related eye disease case studies from an optometric practice specializing in diabetes care. The focus will be prevention of diabetes, diabetic eye disease and attendant macrovascular events, as well as appropriate referral to retinal specialists and endocrinologists when indicated.

This course will consider the impact of various sleep disorders on ocular and systemic disease, and various strategies to improve quality and healthful quantity of sleep. The epidemiology of the most common sleep disorders - hypsomnia, hypersomnia, and obstructive sleep apnea (OSA) - will be presented, including diagnostic parameters and therapeutic targets to mitigate prevalent eye diseases impacted by sleep.
